"The gap is really stretching the organization," says **PDAC Mining Matters** president Patricia Dillon. "It is essential that we connect with more people who can lend their support by giving."



We showcase the mining world for students and teachers at the *2009 PDAC International Convention, Tradeshow and Investors Exchange* and the *Mining in Society Show* and have successfully promoted mineral exploration and mining as career options for young people, reaching out in particular to Aboriginal youth in their own communities.

### **The Big Picture**

The staff at **PDAC Mining Matters** has been busy over the last year. While maintaining existing partnerships and programming, we've cultivated

new partnerships, further expanded our programming, and offered our resources across Canada. Project funding from the Mining Industry Attraction, Recruitment, and Retention Strategy administered by the Mining Industry Human Resources Council has made recent curriculum expansion activities and resource

production possible.



In Ontario, the updated **PDAC Mining Matters** Grade 4 *Deeper and Deeper* resource debuted in September 2008. Since then, we've delivered several preand in-service teacher workshops.

In Manitoba, for the second year running, we presented teacher workshops at the Education, Citizenship and Youth Summer Institute. Thirty-seven educators participated in workshops for three **PDAC Mining Matters** resources. The participants were impressed by the alignment of our resources to the Manitoba

education curriculum and by the contents of our kits. We are now working on identifying and training Manitoba-based facilitators for future **PDAC Mining Matters** workshops.

This year, we doubled our Aboriginal Youth Outreach Program efforts, participating in two camps. At the 2009 First Nations Natural Resources Youth Employment Program (FNNRYEP) in Upsala, Ontario, we repeated our successful 2008 program and in Manitoba, we participated in the inaugural five-week Manitoba Rangers Program.

We partnered with ESRI, a geographic information system software company, to develop digital activities for our senior high school resource, *Discovering Diamonds*. These activities will be showcased as part of a **PDAC Mining Matters**/ESRI joint workshop at the Ontario Association of Geographic and Environmental Educators Conference in October. We also worked with Science North, developing resources to accompany their travelling exhibit, *Diamonds*.



In British Columbia, we have partnered with the Mineral Resources Education Program of British Columbia in an effort to build workshop-training capacity in the province. Two teachers were identified and trained to deliver our senior curriculum resource, *Discovering Diamonds*.

### **Newfoundland and Labrador**

In Newfoundland and Labrador, we are cultivating interest in **PDAC Mining Matters'** education programming and resources. In November, we will deliver educator workshops and participate in the *Mining in Society Show* planned in conjunction with the Newfoundland and Labrador Provincial Mining Week.

### Onward and Upward

Future work involves translating resources into French, expanding programming to Québec, increasing workshop delivery and student reach, producing new resources, and cultivating further education, industry, and government partnerships. By focusing on these areas, we hope to increase student interest in Earth science and mineral exploration, as well as mining industry careers.



### **Reaching out to Aboriginal Youth**

For a second year, **PDAC Mining Matters**, in partnership with Outland Inc., delivered Earth science and mineral industry educational programming for Aboriginal youth aged 16–19 at the First Nations Natural Resource Youth Employment Program (FNNRYEP) in Upsala, Ontario. Celebrating its tenth anniversary this year, FNNRYEP welcomed thirty Aboriginal youth from eighteen different communities, from Kenora to Kirkland Lake. And, building on the success of last year's FNNRYEP, **PDAC Mining Matters** also presented programming at the Manitoba



Rangers Program—an expansion, first-year, pilot camp program based on the FNNRYEP model. Fourteen youth attended from ten different communities, from Shamattawa to Opaskwayak Cree Nation.

**PDAC Mining Matters** provided six days of thematic educational programming in Ontario and eight days in Manitoba. The themes included introduction to rocks, minerals, mining, and geology; mineral exploration; environmental science; careers in the mining industry; and

land reclamation and rehabilitation. The Ontario session included a tour of North American Palladium's Lac Des Iles Mine operation, and in Manitoba, HudBay Minerals provided a tour of their mining and smelting operations in Flin Flon.

Success at the outreach camps is due to the efforts of our Aboriginal Education Specialist, Barbara Green Parker, and Coordinator, Administration and Communications, Amanda Dillon, as well as all the mentors, and government and corporate partners who have supported these important initiatives. We greatly appreciate their time and dedication.

Funding from the Ministry of Research and Innovation's *Youth Science and Technology Outreach Program* supported **PDAC Mining Matters'** participation in FNNRYEP for the past two years. This support has ended, and we are currently looking for new funding for our Aboriginal outreach efforts.

## **Donating Shares**

Donating shares to a charitable non-profit organization such as **PDAC Mining Matters** may be of particular interest to those in the mining industry, due to the considerable tax benefits that can be realized.

The elimination of capital gains on stocks, bonds, and mutual funds means that your contribution to **PDAC Mining Matters** will result in a tax receipt equal to the fair market value of your gift. Rather than being subject to the 50 per cent capital gains tax payable on shares sold during your lifetime, accrued capital gains on donated shares are exempt from taxes. In effect, the tax benefit arising from your gift is the same as if the donated securities were cash.

The donation of flow through shares can produce even greater benefit, as a deduction is offered at the time of purchase and a tax credit is generated when the shares are gifted.


